1. INTRODUCTION

You accept full responsibility for the content You generate and agree to immediately report any violations of applicable laws or this Agreement.

Members are strictly prohibited from using the Service to generate content that violates any applicable laws or regulations, including but not limited to laws relating to child pornography, obscenity, privacy, intellectual property, or discrimination. You expressly agree not to input prompts or data that could lead to the creation of illegal or objectionable content.

3. MEMBER CONDUCT

As a Member, You agree to use the Service in a lawful and responsible manner. Any misuse of the Service, including but not limited to the following activities, is strictly prohibited:

- Generating or attempting to generate content that depicts minors in any sexual context, including “lolicon,” “shota,” or similar themes.

- Inputting deceptive, fraudulent, or defamatory material.
- Violating intellectual property or privacy rights of third parties.
- Disseminating false information or data intended to harm others.
- Engaging in activities that violate any local, national, or international laws.
- Generating any other depictions which we determine contravenes this Member Agreement or our Terms of Service.

Members must report any suspicious, inappropriate, or illegal behaviour encountered on the platform. The Company reserves the right to investigate and take appropriate action, including but not limited to termination of Your account and referral to law enforcement.

The Company retains full control and discretion over the AI Content and reserves the right to remove, modify, or delete any content at any time without prior notice. You acknowledge that the Company may monitor inputs and outputs generated on the platform to ensure compliance with this Agreement.

5. INTELLECTUAL PROPERTY RIGHTS

All AI Content generated through the Service is the exclusive property of Create Porn.
