## 1. INTRODUCTION

This Privacy Policy describes how the website www.createporn.com ("Create Porn"), collects, uses, and shares information about you and applies to your use of www.createporn.com or any of our Affiliated Websites (the "Site"), and all content and services that Create Porn owns, controls, and makes available. By using the Site and Create Porn's services, you agree to Create Porn's Terms of Service and all other terms as described by this Privacy Policy. If you do not agree with this Privacy Policy, you must discontinue use of the Site and Create Porn's services. This Privacy Policy is fully incorporated into Create Porn's Terms and Conditions, and therefore governs your use of the Site and Create Porn's services. By using the Site and Create Porn's services, you do hereby accept this Privacy Policy. All capitalized terms used in this Privacy Policy or in any notice given under or in connection with this Privacy Policy have the same meaning in this Privacy Policy or notice as in the Terms and Conditions, unless expressly defined otherwise in this Privacy Policy.

### 2. WHAT DATA WE COLLECT AND HOW WE COLLECT IT

Our company collects the following data:

- Personal identification information/Membership Data (Email address)
- Internet Activity Information (IP address, referring website information, internet browser used, zip code and/or other data regarding search history, browsing history, registration and user history)
- Device Information (web browser, IP address, time zone, cookies)

Our company records and logs the following data in connection with User accounts:

- View Count
- Liked Images
- Saved Images
- Generation History

- Payments & Subscription History
- Gems Transaction History
- Affiliate Information (Record user's referring website)

Your username and email address are considered confidential. However, all information you provide to us may be shared with other third parties as necessary to comply with applicable law or to cooperate with law enforcement. Information we may collect from you during the sign up process requires that you provide us with certain information which may include Membership Data, Financial Data along with Demographic Information.

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information".

We may use information about you, including your personal information, for any purposes consistent with the statements under this Privacy Policy and as permitted by the applicable law, including, but not limited to:

- Managing the Site and our services.
- Processing and facilitating your transactions.
- · Responding to inquiries and requests;
- Sending you notices, updates, changes to policy information, and support and administrative messages.
- Preventing fraud, breach of our policies or agreed terms, and harm.
- Monitoring usage and activity.
- Improving the Site and our services.

We may also share your information with any third parties in order to fulfill any products or services that you purchase from the Site, and for any purpose consistent with this Privacy Policy or as permissible under applicable law, including, but not limited to:

- Complying with the law, and where required, in response to lawful requests by public authorities, including to meet law enforcement requirements.
- Protecting the rights, property, and security of Create Porn, its services, or any third party.
- In connection with any proposed merger, purchase, sale, or any other type of business acquisition or combination of all or any portion of our assets, or transfer of all or a portion of Create Porn to another company in order to facilitate the transaction.
- For purposes disclosed to you when you provide Create Porn with personal information.
- With your consent or at your discretion.

We collect Device Information using the following technologies:

- "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier.
- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons", "tags", and "pixels" are electronic files used to record information about how you browse the Site.

Additionally when you make a purchase or attempt to make a purchase (such as a membership Subscription or Gems) through the Site, we collect certain information from you, including your name, billing address and email address. We refer to this information as "Order Information". When we talk about "Personal Information" in this Privacy Policy, we are talking both about Device Information and Order Information.

## 3. HOW DO WE USE YOUR PERSONAL INFORMATION AND DATA?

We use the Order Information that we collect generally to issue purchased Gems and/or activate the membership Subscription that you have selected to sign up for through the Site (including processing your payment information). Additionally, we use this Order Information to:

- Communicate with you;
- Screen our account for potential risk or fraud; and
- To improve the information that the Site provides to its customers regarding the services and products which are being sold.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site).

### 4. STORING AND SHARING YOUR DATA AND PERSONAL INFORMATION

We securely store your data using servers hosted by Umami and Cloudflare. Information collected by Umami and/or Cloudflare may be stored in the Service providers' regional data centers. The transfer and storage of your information and data are made in accordance with the terms and policies of Umami and/or Cloudflare. The right to erasure - You have the right to request that we erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Create Porn restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Create Porn's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Create Porn transfer the data that we have collected to another organization, or directly to you, under certain conditions.

The right to complain to a supervisory authority – You can complain about our processing of your personal data.

**The right to withdraw consent** – To the extent that the legal basis of our processing of your personal data is consent, you have the right to withdraw that consent. Withdrawal of consent is effective upon our reception of reasonable notice.

We may use cookies to identify potentially problematic Users, and act accordingly upon that information to ensure the safe and uninterrupted provision of our products and services to our Users.

#### 9. HOW TO MANAGE COOKIES

### 12. DO NOT TRACK
